ABA Urges Congress to Renew Eviction Moratorium

ABA President Refo to Congress: Renew COVID-19 Eviction Moratorium to Prevent Crisis

If the current moratorium on evictions is allowed to expire on December 31, it could result in a spike in both unemployment and homelessness and a dramatic increase in demand for legal services and social services, warned ABA President Patricia Lee Refo. In a letter last week to House Speaker Nancy Pelosi, Senate Majority Leader Mitch McConnell, House Minority Leader Kevin McCarthy and Senate Minority Leader Charles Schumer, Refo urged passing a renewal of the eviction moratorium and essential economic relief for rental property owners. Diversity and Inclusion Survey Finds Legal Profession Lags Behind and Is Losing Ground

In a recent survey by the Minority Corporate Counsel Association, the legal profession was found to lag behind other, comparable professions in diversity and inclusion and to have lost ground on several metrics in the past two years. For example, on a metric called "belonging," law firms and legal departments scored well below professional services counterparts such as accounting and consulting firms. According to Bloomberg Law, this indicates that many respondents, especially lawyers of color, feel that they can't be themselves at work and that their voices are not heard. Where else is the legal profession behind other professions, and how do the most recent scores compare to those from 2018?

State Bars in Nevada, Iowa, and Texas Debut or Spotlight Innovative Programs in Legal Services Delivery

As we head toward a new year, the momentum toward innovative delivery of legal services shows no signs of slowing. For example, the State Bar of Nevada is launching an incubator program to begin in March 2021. The Handle|BAR Incubator Program is "designed for those with an entrepreneurial spirit and enthusiasm about serving low-and modest-income clients," according to the bar's website. The Iowa State Bar Association Rural Practice Committee is starting a mentoring program specifically for law students who are considering rural practice. An ISBA news item says about a dozen law students have expressed interest. Meanwhile, in his executive director's column, Trey Apffel of the State Bar of Texas highlights the ways participants in the Texas Opportunity & Justice Incubator have adapted and thrived during the pandemic.

Executive Director Candidate Files \$2.9 Million Discrimination Claim Against State Bar of California

A former statehouse attorney is suing the State Bar of California for \$2.9 million, alleging that she was offered the job of executive director but was then told the offer was rescinded without explanation. Fredericka McGee, who is African American, alleges that the bar's board of trustees breached a contract with her, engaged in discriminatory hiring practices, and violated her privacy. In a statement, a spokesperson said that the bar does not agree with the factual and legal statements in McGee's claim.
