

ABA President Speaks out Against Hate Crimes & Discrimination Against Asian Americans

ABA President Patricia Lee Refo Makes Statement on Discrimination, Hate Crimes Targeting Asian Americans

"People need the protection of the government and the law," wrote ABA President Patricia Lee Refo, in a statement issued last week on the subject of hate crimes and discrimination against Asian Americans. "But we all bear the responsibility and moral duty to stand up for our neighbors and ensure they are safe and respected." Refo's statement shares data regarding a pandemic-related increase in such incidents and commends U.S. Attorney General Merrick Garland and the Justice Department for its recently announced 30-day internal review of how these incidents are tracked and prosecuted. Rhode Island Lowers Bar Exam Cut Score, Other States Consider Changes

After California permanently lowered the cut score on its bar exam in summer 2020, it saw a significant increase in the diversity of bar applicants who passed the exam and became new lawyers. Now, several other states are following suit, or are monitoring changes being made by the National Conference of Bar Examiners with an eye toward possible changes in their jurisdictions. For example, last week, Rhode Island announced that it had lowered its cut score, and a spokesperson for the Idaho Supreme Court said scoring changes may be considered in that state.
