Maryland Closer to Implementing Mandatory CLE Courses

The Supreme Court of Maryland released a report recommending the implementation of mandatory CLE for attorneys in the state. The work group consisted of attorneys, legal academics, and judges. The report also recommended that the state align itself with the CLE requirements of neighboring state jurisdictions in order to make it easier for attorneys practicing in multiple states to fulfill requirements. Report: Public Defenders are Overworked

A new report states that public defenders are overworked and struggling to provide sufficient legal representation for their clients. A team of attorneys and researchers from a variety of public and private organizations—including the ABA—found that the 50-year-old guidelines for public defender caseloads are outdated and inadequate.
